## 4. Land Acknowledgement

Vice-Chair Coveney provided the following land acknowledgement:

The Niagara Parks Commission wishes to acknowledge and honour the lands along the Niagara River corridor as the traditional territory of Indigenous peoples. In both spirit and partnership, we recognize and thank the Six Nations of the Haudenosaunee, the Mississaugas of the Credit First Nation of the Anishinaabek, the Neutral Nation, and all who provided stewardship of these lands over millennia. Recognition of the contributions of Indigenous peoples is consistent with our commitment to making the promise of Truth and Reconciliation real in our communities. We are grateful for the opportunity to live, work, and play here and thank all those who have served and continue to serve as caretakers of this special place.

# 5. Chair's Opening Remarks

Vice-Chair Coveney requested that the recording secretary read aloud the names of Commissioners and staff around the table.

The Vice-Chair welcomed those in attendance and provided the following remarks:

"Looking back at the last few weeks since our August meeting, on Saturday and Sunday, August 10-11 we hosted another successful battle reenactment weekend at Old Fort Erie the largest battle reenactment in Canada. Hundreds of reenactors travel across North America to participate in this annual event. On August 24, Chair Gale and CEO David Adames led a tour of the Niagara Parks Power Station for a group of 25 Consul Generals from the Consular Corps in Toronto. The tour was facilitated through the Niagara Economic Development Team and the group also attended the World Rowing Championships Nations Dinner that evening. On Sunday, August 25, Chair Gale attended the Sree Krishna Janmashtami celebration at Oakes Garden Theatre. Wednesday, August 28, we partnered with Susannah Goshko, the British High Commissioner to Canada and Consul-General Fouzia Younis to host a spectacular reception at Table Rock to celebrate the 60th diamond season of the Red Arrows. Both Chair Gale and Mayor Diodati spoke at the event and I know there were some Commissioners in attendance as well. The Red Arrows were scheduled to do a flyover of the Falls that evening; however, it was cancelled due to weather. Despite that, the event was a great success and very well attended. A big thank you to everyone involved in the planning and execution of that event at Table Rock. Labour Day weekend marked the final long weekend of the summer season and once again we saw strong visitation with Sunday being the busiest, followed closely by Saturday. In keeping with our holiday road closure schedule, the Niagara Parkway and Clifton Hill were closed to vehicular traffic both Saturday and Sunday evening beginning at 7pm. These road closures help to increase



safety for pedestrians and cut down on traffic and congestion by the Falls during higher visitation weekends. Labour Day was also the final day of operations for our Niagara's Fury 4D attraction at Table Rock Centre. This attraction opened in 2008 and has since reached the end of its lifecycle due to the aging technology. Construction is now officially beginning to prepare for the new attraction set to open in the summer of 2025. A series of communications were sent about this project, including our call for volunteers to participate in the filming for the new attraction on certain dates. Commissioners should have also received information about this as well. Effective September 3, Niagara Parks officially took over operation of the WEGO Blue Line. We now operate both the WEGO Green and Blue Lines, ensuring guests have access to an integrated public transit system in the destination. Our team worked with the Niagara Transit Commission on the roll-out of these changes to help ensure a smooth transition. Tomorrow, Niagara Parks is hosting a launch event for a new book entitled, Landscape of Nations: Beyond the Mist, which we'll hear more about in a moment during our first presentation. Continuing on, as part of our protocol, we do not permit questions from the public during the meeting proceedings.
