The Niagara Parks Commission wishes to acknowledge and honour the lands along the Niagara River corridor as the traditional territory of Indigenous peoples. In both spirit and partnership, we recognize and thank the Six Nations of the Haudenosaunee, the Mississaugas of the Credit First Nation of the Anishinaabek, the Neutral Nation, and all who provided stewardship of these lands over millennia. Recognition of the contributions of Indigenous peoples is consistent with our commitment to making the promise of Truth and Reconciliation real in our communities. We are grateful for the opportunity to live, work, and play here and thank all those who have served and continue to serve as caretakers of this special place.

## 5. Chair's Opening Remarks

Chair Gale requested that the recording secretary read aloud the names of Commissioners in attendance.

The Chair welcomed those in attendance and provided the following remarks:

"Good morning, everyone, and welcome to our December Public Commission Meeting. At our last meeting, we were preparing for the launch of this year's Winter Festival of Lights. And now, the festival is in full swing. I hope Commissioners have been able to check out some of the displays and new programming this year – Queen Victoria Park is looking better than ever. The Festival will continue through to January 4, including nightly fireworks between December 25 and January 4. Niagara Falls is a popular destination for many over the holidays – whether guests are coming for the day or spending a couple nights in the destination - there is plenty to see and do. Looking back over the last few weeks, on November 18, I provided a welcome to delegates in Niagara Falls for the National Golf Course Owners Association Conference. We also hosted their opening reception at the power station that evening. November 18 – 20 was the Tourism Industry Association of Canada's National Tourism Congress held in Gatineau, Quebec. David attended the conference and delivered a presentation about Niagara Parks' recent investments to improve our visitor experiences and the ROI we've achieved as a result. That week, Museums Canada hosted events in the national capital region as well and David delivered a presentation about guest feedback collection and implementation, as well as a talk on revenue innovation. On November 21, I was pleased to attend the Coldest Night of the Year launch event at Table Rock. This is a fantastic local initiative that raises money for local charities serving people experiencing hurt, hunger and homelessness in our communities. The launch event was held to raise awareness ahead of the annual walk will take place on February 28. Thank you to Commissioner April Cotton for attending and speaking at the Zonta Club of Niagara Falls' Candlelight Vigil at Table Rock on November 24. This annual event marks the kick off to 16 days of activism in support of ending gender-based violence. Thank you as well to Inspector Lepa and Constable Paul from our Police for attending."

"On December 3, I was pleased to attend an event in support of the Niagara Parks Foundation's Silent Auction to raise funds for the Children's Garden. The auction raised over \$30,000 in support of the upcoming project to build an interactive Children's Garden at the Botanical Gardens. Thank you to everyone who participated for your generosity and congratulations to the winners! We'll now continue with the rest of our public meeting."
